Introduction^{1 2}

Since the Syrian uprising of March 2011, the Syrian archaeological heritage has been suffering. Many articles and photos have been published and disseminated online to inform and document the damage to the Syrian cultural heritage, emphasising not only the importance that ancient sites and historic buildings have assumed in the history of Syria, but how their protection is now crucial to preserve the cultural identity of the Syrian people.

This report offers a summary of the actions that have been undertaken by different bodies and organisations towards the protection and the conservation of the tangible cultural heritage from the beginning of the Syrian uprising up until March 2014. International acknowledgement of the crisis has been expressed and responses launched through actions such as documenting and updating information involving social media (i.e. Facebook, YouTube, websites, blogs, etc.), and short-term (i.e. petitions, statements, press releases, etc.) and long-term projects (i.e. lectures, exhibitions, workshops, training, etc.).

It is necessary to provide a summary of these actions to increase international awareness, strengthen collaborations between scholars, and establish contacts between individuals, organisations and stakeholders interested in this matter. International responses are presented in alphabetical order according to the name of the organisations or stakeholders involved. The organisations that have been newly founded specifically to help the protection of the Syrian cultural heritage are characterised in this report by an asterisk (*) located after the name. Further details about the type of response and project organisers can be found by following the links.

This compendium does not provide a comprehensive discussion of those carrying out these actions, their intentions or their methodology, but it gives links where such information can be found and further analysed. This contribution focuses only on organisations which either deal exclusively with heritage, or which have specific projects addressed to it. However, the contribution of citizen journalists, such as the Young Lens organisations, bloggers, and other groups, to awareness raising must be acknowledged, although they are not specifically devoted to heritage protection. Bibliographical references, and press articles are not included in this report.

Directorate-General of Antiquities and Museums (DGAM)

- *Location and date founded:* Syria, 1946.
- *Description:* The DGAM is a Syrian government organisation responsible for the protection, promotion and excavation activities of all sites in Syria. Since 2011, the DGAM has been involved in many actions to safeguard and protect the cultural heritage, which include:
 - a) online publication of annual reports;
 - b) a book titled *Archaeological Heritage in Syria during the Crisis 2011-2013* on the damage to the archaeological heritage;
 - c) The *Syria: My Homeland* initiative, which aims to raise awareness amongst local communities about the great value of their national heritage, to encourage them to take pride in its constituents and to protect it from theft and sabotage using multiple forms of advertising and campaigning;
 - d) an electronic database of the Syrian archaeological sites (completed in November 2013);
 - e) In June 2013, the DGAM published maps documenting the damage to Syrian archaeological sites;
 - f) the creation of a .kmz layer detailing damage to the cities of Homs and Aleppo (for Google Earth);
 - g) the formation of a committee in charge of the restoration of the old city of Aleppo (September 2013);
 - h) in collaboration with UNESCO, the DGAM is engaged in a project called *Save Syria's History*. This project aims to combat illicit trafficking by running courses to enhance staff capacity in the fields of protection, documentation (i.e. posters and other audio-visual material widely disseminated around Syria), restoration and setting future plans for restoration and rehabilitation;
 - i) in collaboration with the UNESCO's offices in Beirut and Amman, DGAM is involved in a project against illicit trafficking of archaeological objects (see also UNESCO);
 - j) in collaboration with the Minister of Culture and with Dr Hamad al-Hammami (director of the UNESCO Regional Office for Arab States in Beirut), in February 2014 the DGAM announced the launch of a project to protect the Syrian cultural heritage which will start in March 2014 for three years (see also UNESCO);
 - k) the restoration of the mosaics of the Umayyad Mosque in Damascus;
 - l) the completion of a draft new law for the protection of the Syrian archaeological heritage;
 - m) a formal Memorandum of Understanding between the DGAM and the Regional Planning Commission to help prevent illegal building on archaeological sites;
 - n) the digitalisation of hundreds of rare drawings of historical buildings and significant archaeological sites in Aleppo;
 - o) in collaboration with ICOMOS, ICCROM and INTERPOL, the DGAM is involved in a project for the protection of the old city of Damascus (Jan 2014).

 - d) including the *Cultural Heritage Sites of Syria* within the *2014 World Monuments Watch*, which highlights 67 sites from 41 countries which are under threat from war, the environment, or economic development;
 - e) WMF received an appeal from the Syrian authorities to help preserve three key sites: Aleppo's historic center, Krak des Chevaliers, and the medieval fortified city of Qal'at al-Mudiq. These sites are their priority. The first step will be planning, documentation and analysis of damage. A great deal of work will be conducted offsite thanks to the powerful resource of satellite imagery, radar scanning, and the monitoring that many people inside Syria are doing on the ground. From 2000 to 2010, WMF and the Aga Khan Trust for Culture worked extensively on the restoration of Aleppo Citadel. The knowledge and experience gained will guide their mobilization sometime in the future.

Within the 38 bodies considered in this report,

- Fourteen of them have been recently founded in reaction to the Syria crisis. The majority of these are formed from volunteer members. The greater number of these bodies have a national foundation: six of them are Syrian.
- The majority of the project teams are formed from international members and collaborations (29 out of 38). The types of actions undertaken by these groups include: discussion and sharing updates online, publications (i.e. articles, books, maps), interviews, statements, press releases, petitions, lectures, conferences, workshops, training, exhibitions, electronic databases (of both archaeological sites and objects), urban restoration projects; control measures help to detect illicit trafficking of cultural objects, establishing awards, and proposing new draft laws.
- The most common actions have been carried out through online discussions (23 out of 38), while electronic databases and measures to combat the illicit traffic of cultural objects have been launched by only five groups.
- Finally, workshops and training for Syrian people have been organised by eight organisations, but they refer to similar projects undertaken in cooperation (i.e. ICOMOS, and ICCROM)

The numbers provided in this report are obviously provisional and they only refer to the groups whose information is available on the internet. It is important to emphasise this aspect and to encourage people who are not included in this list, but working toward the protection of the Syrian cultural heritage, to come and share their projects. This is essential not only for better organisation of types of activities and projects, but also to make larger international organisations aware of the need of more funding, which is essential to ensure the achievement of the teams' goals.
